
## MESSAGE FROM THE CHAIRMAN



The Tender Board has achieved remarkable success and a prominent reputation since its establishment five years ago. As a result of the Board's dedication in conducting its operations with the highest integrity and exceptional transparency, it is now distinguished for attaining world-class standards. The Board is steadfastly committed to protecting public funds to prevent the influence of personal interests, while achieving economic efficiency, ensuring fair treatment and equal opportunity amongst all suppliers and contractors, and above all, to achieve total transparency in all aspects of government purchasing procedures.

To ensure maximum expediency, members of the Board hold uninterrupted weekly meetings to review and discuss matters and procedures related to the government tenders and purchases, to review and study all correspondence and to ensure that sound decisions are reached. The Board has experienced an increase in public purchases because of the rise in government owned businesses. Moreover, with the Board's rising reputation, it has witnessed an increase in demand, making its weekly meetings even more crucial. The growing interest in government projects amongst suppliers and contractors is attributed to their confidence in the Board's integrity to award the tenders to the most technically qualified bidders with the lowest price; the bidders value the impartiality and the opportunities available. Although the Board comprises a small team of board members and staff members, they are however, capable of processing and handling high volumes of bids and bid related matters because of their open communication, prompt interaction, tight and flexible organizational structure, together with an advanced database, quality control and a good archiving and retrieval system.

With one of the most advanced operational systems in the region, the Board has become more efficient and accurate with the implementation of its state-of-the-art databank, archiving and communication systems. The recent initiation of the Live Opening session of Tenders will enhance the transparency while accelerating operations and facilitating communication between the Tender Board and stake holders, making information more accessible via Tender Board website on the internet.



generating interest, making the bidding process easier and more convenient for suppliers and contractors. Through the Live Opening session of Tenders, bidders have the option of choosing between watching the opening of the tenders online or attending in person the Public Opening sessions on Thursday mornings. These new systems ensure utmost transparency while allowing suppliers and contractors from anywhere in the world to bid at their convenience and view the Live Opening session online.

The Tender Board has established a number of specialized subcommittees consisting of distinguished professionals and experts from various fields. These subcommittees avail to the Board, offering their technical skills and capabilities in dealing with a range of requirements such as the pre-qualification of contractors and suppliers, ratification of technical specifications, reviewing of complaints and reconsiderations, and the supervision of the opening of tenders for bids of less than BD 500,000/- in cost.

In 2007, new amendments have been recommended to the law regulating government tenders and purchases to streamline some procedural aspects which will be of benefit to all those concerned. One such modification dealt with the execution of the tenders and the effectiveness of the related contract after being awarded by the Board. Previously the Law stated that a contract shall be effective immediately upon the issuance of the award decision by the Board to the successful bidder. This term is now amended so that a contract shall not be effective until the Purchasing Authority officially informs the successful bidder about the Board's decision to award the tender to him. Now all contracts between purchasing authorities and successful bidders will no longer be effective immediately upon the issue of the award decision, but upon the communication of such a decision. This amendment allows the unsuccessful bidder to file a grievance to the Tender Board if they deem so. Subsequently, if such a complaint is lodged, the Board has the authority to issue temporary precautionary measures to order the purchasing authority to stop implementing the Award Decision until a decision in the grievance is delivered by the Tender Board. To benefit the most from the Board's diverse expertise and to ensure continued progress, another amendment related to the term of membership of the Board members has been introduced. It states that any Board member's term in office shall be determinate to two years, renewable once. Two thirds of the Tender Board may be reappointed for another term,

provided that no member remains in office for more than six consecutive years. In the upcoming year, the Board anticipates new amendments to the law that will give the Board more influence, benefiting the public authorities and the tenderers. One major projected amendment relates to entrusting the Tender Board with the responsibility of overseeing government auctions and the syndication of the selling of government property.

As a result of the board's commitment to achieving excellence in economic efficiency, implementing principals of transparency, fairness, and opportunity, while contributing towards heightening Bahrain's investment position on the global map. The keenness of the Tender Board on enhancing the principle of transparency in all procedures followed in Government tenders and purchases has enhanced the Tender Board's reputation. For example, Standards and Poor's organization, which focuses on evaluating nations and major development plans, pointed out that among the factors that contributed to improving the investment standard of Bahrain was the policy of the Tender Board to bolster the principle of transparency in tendering procedures. The Board also received the ISO certificate for Management Excellency, ISO 9001:2000. Last year, the Tender Board realized many significant achievements that have had a tremendous impact on procedures, and have helped the Board to provide higher quality services, more expedient response times and more transparent treatment of information.

The Tender Board's high standards in supervising and overseeing all tenders for the purchase of goods and services from the public sector organizations has played a significant role in encouraging investors' confidence in the nation's economy. The Board's devotion to upholding Bahrain's ambitious course of economic, business and social reform will not only benefit the Kingdom, but it will also contribute to the ongoing growth and prosperity of the Gulf region and the Middle East.


# KEY ACHIEVEMENTS

## LIVE OPENING SESSION OF TENDERS

Recently introduced to the Tender Board website, the Live Opening session completely automates the 'Public Opening session of Tenders', relaying all of the biding information to the website in real time. Every Thursday morning, as bids are opened and shown at the Public Opening session, they are also presented online, enabling all those concerned to view the entire Public Opening session online via the Live Opening function on the website. All bid related information that is presented at the Public Opening session is also presented simultaneously on the Live Opening session in a clear and transparent manner. As the members of the Board (or the Tender Opening Committee) go through each bid at the Public Opening session, and as each form is displayed on the overhead screen, the exact image of the form is shown on the Live Opening session web page indicating the bid, the name of the supplier, and the company. This allows suppliers and contractors the freedom of either attending the Public Opening session in person or viewing the opening of tenders online at the Tender Board's website.

In the upcoming year, as an additional feature to the Live Opening session web page, the Board plans to install a webcam in the Public Opening session room that will show all the bid opening activities in the Public Opening session in real time manner. This will give suppliers and contractors the freedom to alternate between the webcam caption and the submitted bids. Obviously, this initiative will enhance the transparency of the Tender Board's operations and add to the convenience of the parties concerned.

The Bahrain Tender Board is one of the first of its kind in the world to offer Live Opening sessions. Through the internet, suppliers and contractors are able to view the Public Opening sessions from anywhere across the globe. This function will improve the operations of the Tender Board by making government tenders and acquisitions more accessible and transparent. Live Opening sessions of Tenders encourages international and local firms to participate in the tenders, consequently opening Bahrain to international companies and helping the government to obtain fair and competitive prices for its tenders and purchases.




## WEBSITE

The Tender Board website was revitalized with a fresh new look, a clean layout and a user-friendly interface. These new enhancements grant the users easy access to all Tender Board information including Laws and Regulations, Upcoming Tenders, Tender Notices, Operational Reviews, News & Events, and much more. The Live Opening session of Tenders is a major new service that was recently introduced on the website, allowing users to view Public Opening sessions online. The IT department continues to provide comprehensive support to the website users.

## RECONSIDERATION & COMPLAINTS

The Tender Board dealt with a total of 104 requests for reconsideration and complaints during 2007. All such requests were studied by the Tender Board in the light of the Law Regulating Government Tenders and Purchases and appropriate decisions were made in full transparency to ensure adherence to the principles of fairness and equality. Most of the requests for reconsideration and complaints reached the Tender Board were related to the procedures followed by Government Authorities in issuing, evaluating and awarding tenders. Throughout the past five years since the establishment of the Tender Board, only two cases have been sent to the court and these claims have been declined by the court. The Tender Board received frequent messages of praise and appreciation from suppliers and contractors for its fair, efficient and transparent disposition of duties.





## QUALITY MANAGEMENT SYSTEM

To assist in the continual improvement process of the Tender Board's Quality Management System (ISO 9001:2000), a new task has been introduced to systematically formalize and develop Key Performance Indicators (KPIs). This new task ensures that the Tender Board's performance is monitored and measured regularly, while upholding the Quality Management System requirements and applying the international operational best practices.

The KPIs will function to monitor and support the overall performance of the Tender Board in a systematic manner, applying professional data collection methods and using sophisticated tools for analysis. This task is dedicated to measure and manage the Tender Board's performance as a consolidated business unit. This includes tender preparation, bid submissions, bid openings and awards, reevaluation of bids, reconsideration and complaints, staff training and development, Board-related purchases and other processes.

The Tender Board's Quality Management System has achieved accreditation to the International Standard (ISO 9001:2000) in November 2006. The year 2007 has been devoted to improvement of Tender Board's Quality Management System and fulfilling its requirements to uphold this international accreditation.

## **E-TENDERING**

The first initiative of its kind in the region, the Tender Board is in the process of introducing a new electronic tendering system (e-tendering) that automates the tendering process in its entirety, enabling greater accuracy, efficiency and transparency. The e-Tendering is an electronic system that will allow publishing, communicating, accessing, receiving, and submitting of tender related information and documentation via the internet. When launched, it will handle all the government tenders and acquisitions online, primarily by posting bids, filling out documentation, regulating the quality of information received, and opening bids.

The development of this extensive e-tendering system first started in September 2007 and it is still in its initial stages of development. The e-tendering system is estimated to be fully functional, by April 2008 with a three month testing period during which, both manual tendering and e-tendering services will be available to cater to individual preferences. The eventual migration to a full-fledged e-tendering system, replacing the manual process in its entirety, is projected to transpire within the next year.

The e-tendering system will facilitate all Tender Board operations considerably. Everything will be organized on an online system, streamlining the submitting, managing and receiving of tender documents, while enabling easy access to information. It will serve as an important tool in speeding up the decision making process, helping the Tender Board reach accurate decisions. e-tendering will cut costs, reduce processing time, allow for more efficient monitoring of applications, increase the overall quality of services while reducing the number of complaints, and allow for greater transparency of decision making.

With the introduction of the e-tendering online platform, there will no longer be any physical requirement for contractors and suppliers to come to the Tender Board's offices in person; everything can be submitted and tracked online. If there happens to be missing or inadequate information, the system will alert the applicant immediately, preventing possible rejection of bids




at the opening sessions due to routine errors. Since bids can be placed and monitored online, from anywhere in the world, the quality and range of suppliers and contractors is estimated to improve significantly. The higher number of bidders will provide greater selection, competition and added value, which will eventually lead to increased protection of the public property.

With the introduction of e-tendering, the Bahrain Tender Board will join the ranks of the leading international tendering and purchasing bodies. The Board holds ambitious plans to eventually link the e-tendering system with Bahrain's eGovernment platform, enabling access to pertinent information from relevant ministries.

## TRAINING & DEVELOPMENT



Owing to the upcoming developments as well as the new advancements introduced in past years, there emerged a need for additional training in order to equip the staff members with the skills and proficiency required to interact with these new systems and to be fully familiar with the new procedures. By continually developing the professional skills of its employees, the Tender Board is fully equipped to reach its ambitious objectives well into the future.


The quantity of mail received by the Tender Board has steadily increased since its establishment. The quantity of mail received in 2007 is nearly doubled what was received in 2004.





The automatic linkage of key information will facilitate the Tender Board's acquisition of relevant data and records from the ministries, suppliers and contractors.

To uphold its high standards and maintain its esteemed certifications, the Board is firmly determined to continue to take the necessary measures to resolutely adhere to the specifications of its new Quality Assurance System and develop it further.

To ensure further efficiency, certain provisions of the law regulating the Government Tender and Purchases have been reviewed, revised and submitted to the authority concerned for approval. The greatly anticipated amendments include overseeing of government auctions, which will make public selling and leasing of government property more efficient and transparent, attract more competition and lead to greater return.



The Tender Board is committed to building upon its remarkable achievements and to uphold its reputation of credibility and trust, while increasing levels of transparency and impartiality. This will be achieved by further streamlining tender procedures, improving disclosure of information to all contractors and suppliers, further enhancing the Board's institutional capabilities.
